- All selected trainees shall be required to pass the examination of Associate Chartered Insurance Institute (ACII) from Chartered Insurance Institute, London OR Fellow Life Management Institute (FLMI) from Life Office Management Association, USA.
- The candidates will be required to acquire a qualification of ACII's Certificate Level / ALMI (5 papers) within the period of training i.e. two years. The successful trainees will be offered employment subject to satisfactory conduct and performance during the training. Thereafter upon acquiring ACII's diploma Level and advanced diploma Level / FLMI, they will be elevated / promoted as per terms and conditions of the contract. Two years retention period is mandatory in a grade.
- The services of trainees will be governed under the State Life Employees (Service) Regulations, 1973, and any other laws & rules applicable to employees of State Life.
- During the period of training medical treatment for trainees (only) and leaves will also be allowed as per entitlement.
- A qualification allowance will be admissible as per rules when placed under employment.
- Other terms and conditions as per employment contract shall also apply.
